Until 2016, Certified Judges and Assistant Certified Judges had supported the ZNA Certified Judge Club by paying the ZNA CJ Club annual fee 10,000 yen. The supporting fee was abolished at the end of 2016. Newly, the program shown below started from 2017: ZNA JUDGING & SEMINAR REGISTERED MEMBER PROGRAM.

ZNA JUDGING & SEMINAR REGISTERED MEMBER PROGRAM

- 1) The new program applies to the following members who want to join it.
 - a. Certified Judge
 - b. Assistant Certified Judge
 - c. Local Certified Judge
 - d. Trainee Judge
- 2) The registration fee is 4,000 yen per year, which includes the following fees.
 - a. Participation fees for two official ZNA seminars held in Japan.(Usually held in January and June)
 - b. Registration fees for ZNA seminars commanded by ZNA Certified Judges, and also for koi show judging experiences.
- 3) All Certified Judges and Assistant Certified Judges should join this program. The registration of this new program is necessary each year.

As for Local Certified Judges, Trainee judges, if he/she doesn't need to have his/her judging or seminar experiences registered and recorded, he/she may decide not to join this program. However, their judging and seminar experiences during a non-registered year are NOT counted at his/her application for the advanced judge status.

<Trainee Judges>

Trainee judges, strictly speaking who are not judges, are considered to be just learning koi appreciation and judging. Those who want to join a judging team of a ZNA chapter koi show for his/her future application for a Local Certified Judge, he/she must join this program by submitting the application form with his/her chapter president's signature and recommendation. Registered Trainee judges are required to be a ZNA chapter member for more than 2 years.

Note: Trainee judges can not attend any judging vote at koi shows.
